

## **A Bill to Require Sexual Harassment Training**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All workplaces shall be required to conduct annual anti-sexual  
3 harassment training for all employees.

4 **SECTION 2.** A. A workplace shall be defined as a place of employment with twenty or  
5 more employees.

6 B. Anti-sexual harassment training must explain a method for how to deal  
7 with complaints as well as state and federal laws about sexual  
8 harassment.

9 **SECTION 3.** The Department of Labor shall be responsible for enforcing the provisions  
10 of this bill.

11 **SECTION 4.** The provisions of this bill shall take effect on April 30<sup>th</sup>, 2020.

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A Bill to Require Schools to Stock Epinephrine**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All public schools in the United States shall be required to stock  
3 unassigned Epinephrine Auto-Injectors.

4 **SECTION 2.** Epinephrine Auto-Injectors shall be defined as a life-saving medical  
5 device used to inject doses of epinephrine to treat symptoms of  
6 anaphylactic allergic reactions.

7 **SECTION 3.** The Department of Health and Human Services in conjunction with the  
8 Department of Education shall be responsible for enforcing the provisions  
9 of this bill.

10 **SECTION 4.** The provisions of this bill shall take effect at the start of the 2020-2021  
11 school year.

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A Resolution to Improve Work Conditions in Distribution Centers**

- 1 **WHEREAS,** Working conditions in distribution centers, also known as warehouses,  
2 continue to cause negative impacts on the well-being of employees; and
- 3 **WHEREAS,** Inhumane conditions such as insufficient A/C or Heat lead to acute  
4 physical illnesses; and
- 5 **WHEREAS,** Lack of attention to human needs such as meal breaks or restroom  
6 breaks are known to incapacitate employees; and
- 7 **WHEREAS** Threats and fear of being replaced by robots cause employees to face  
8 enormous workloads under hazardous conditions; now, therefore, be it
- 9 **RESOLVED,** By the Congress here assembled to demand working conditions in  
10 distribution centers be improved.

## A Bill to Ensure Stability in Yemen

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States shall provide 300 million dollars in humanitarian aid to  
3 Yemen and deploy 1,000 U.S. soldiers to set up relief and refugee camps.

4 **SECTION 2.** A. Humanitarian aid shall include setting up and maintaining relief and  
5 refugee camps defined as temporary accommodations for people forced  
6 to flee their homes to escape violence and persecution.

7 B. Humanitarian aid shall be provided through the cooperation of the  
8 Non-Governmental Organizations (NGO) and the U.S. Government.

9 C. NGO is defined as nonprofit organizations that operate independently  
10 of any government, typically one whose purpose is to address a social or  
11 political issue.

12 **SECTION 3.** The Department of USAID and the U.S. Department of State shall be  
13 responsible for enforcing the provisions of this bill.

14 **SECTION 4.** The provisions of this bill shall take effect on January 1, 2020.

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A Bill to End the United States Trade Embargo Against Cuba**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States government shall end its trade embargo against Cuba.

3 **SECTION 2.** Trade Embargo shall be defined as the series of trade and commercial  
4 activity restrictions placed by the United States on Cuba specifically.

5 **SECTION 3.** The Office of Foreign Assets Control shall be responsible for enforcing the  
6 provisions of this bill.

7 **SECTION 4.** The provisions of this bill shall take effect two months after passage.

8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Increase Spending Transparency**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All currently off budget expenditures will permanently be noted on the federal

3 budget, and as such become on-budget expenditures.

4 **SECTION 2.** A. As used herein, “off-budget expenditures” shall be defined as any current

5 government expenditure not currently listed on the federal budget.

6 B. As used herein, “on-budget expenditures” shall be defined as any government

7 expenditure that is listed on the federal budget.

8 **SECTION 3.** A. The Office of Management and Budget shall be responsible for enforcing the

9 provisions of this bill.

10 **SECTION 4.** The provisions of this bill shall take effect March 1, 2020.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Reform Immigration**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A. The Department of Justice’s sanctioned quota cases on immigration judges are hereby repealed.

3 B. 2 billion dollars shall be allocated toward creating a mandatory training course that all  
4 immigration judges must complete before hearing cases.

5 C. 2 billion dollars shall be allocated toward the appointing and proper training of new judges.

6 D. The Department of Justice’s policy of protection of asylum seekers and refugees based on a  
7 “well-founded fear of persecution” shall be replaced with the definition as follows; admittance  
8 shall require “a reasonable fear of persecution.”

9 E. The annual cap on refugees shall be raised to 50,000.

10 **SECTION 2.** A. “Department of Justice sanctioned quotas” are defined as policies requiring judges to complete  
11 a certain number of cases by the end of each year, as implemented by Jeff Sessions.

12 B. “Mandatory Training Course” shall be defined as a standardized course that would establish  
13 ethical means of presiding over hearings.

14 **SECTION 3.** The Department of Homeland Security shall work in conjunction to the Department of Justice to  
15 oversee the implementation of the provisions of this legislation.

16 A. Funding shall be delegated from Immigration Customs Enforcement (ICE) and Customs and  
17 Border Protection (CBP) as the departments above see fit.

18 B. The House Committee on Border and Maritime Security shall exercise the right to oversee  
19 proper allocation of funding.

20 **SECTION 4.** The provisions of this bill shall take effect The provisions of this legislation shall be enforced on  
21 January 1<sup>st</sup>, 2021.

22 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Increase Contraceptive Availability**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All women aged 18-30 living in the United States shall have fully subsidized  
3 access to contraceptive pills at no cost.

4 **SECTION 2.** A. Contraceptive Pills shall be defined as any drug taken in the tablet form which  
5 prevents pregnancy without risk to the woman.

6 B. Fully subsidized shall be defined as the full coverage of cost for contraceptive  
7 pills in order to eliminate the cost for anyone trying to obtain them.

8 **SECTION 3.** A. The US Department of Health and Human Services, in conjunction with  
9 Planned Parenthood, will be responsible for the implementation of this legislation.

10 B. The US Department of Health and Human Services will allocate \$6 billion per  
11 year to Planned Parenthood to properly implement this legislation.

12 **SECTION 4.** Upon passage this legislation will become effective on January 01, 2020

13 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
