

## FGCCFL Student Congress Chamber Agenda

**DIRECTIONS:** The Parliamentarian should lead the chamber in setting its agenda for the day. The agenda should be set according to these guidelines:

1. B/R whose named author is in the chamber should be scheduled ahead of other B/R.  
**These authors are entitled to an opportunity to present their B/R.**
2. If the author is not in the chamber, another legislator from the school that submitted the B/R **may** act as the author of the B/R (if they do not have a B/R of their own).
3. B/R with no same-school sponsor should be scheduled after all sponsored items. Sponsors for these B/R will be chosen according to the rules of priority as the items come up for debate.
4. Every school with legislation is entitled to present one B/R before any school presents a second B/R.
5. Supplemental items, if any, must be placed at the end of the agenda.
6. **Once set, the agenda MAY NOT be reordered.** However, the chamber may use appropriate procedure to delay consideration of items, e.g., by postponing the Session 1 PO's B/R until Session 2.

**A Bill to Encourage Primary Schools to Teach Foreign Languages**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A monetary incentive of \$5,000 will be given for every 5<sup>th</sup> grade student who is  
3 proficient in Spanish, French, or German on standardized testing on May of each  
4 school year.

5 **SECTION 2.** A. Standardized testing shall be defined as federally mandated, 2-day test called  
6 the FLCE (Foreign Language & Culture Exam).

7 B. Proficiency within a foreign language shall be defined as earning a 70 percent  
8 or higher on the exam.

9 C. The FLCE is optional for all schools and is district mandated. It shall only be  
10 administered to 5<sup>th</sup> graders whose schools are participating in the program

11 D. The monetary incentive will be delegated to the schools through the school  
12 district and shall be used at the discretion of the school

13 **SECTION 3.** A. The Department of Education shall be responsible for enforcing the provisions  
14 of this bill.

15 B. The Department of Education shall allocate \$1 billion towards the funding of  
16 this bill.

17 **SECTION 4.** The provisions of this bill shall take effect August 1, 2022.

18 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Fund the First Year of College**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All students attending a public college shall have their first year fully funded by  
3 the government.

4 **SECTION 2.** Public college shall be defined as post-secondary educational institutions  
5 primarily funded by the government. The first year of college shall be defined as  
6 two undergraduate college semesters, beginning on the first calendar date of  
7 college attendance. The full cost of tuition and books will be included in the  
8 provisions of this bill.

9 **SECTION 3.** A. The Department of Education shall be responsible for enforcing the provisions  
10 of this bill.

11 B. A five dollar charge will be added onto all federal tax returns to finance this  
12 bill.

13 **SECTION 4.** The provisions of this bill shall take effect January 1, 2024.

14 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Allocate Funds for Infrastructure**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States shall spend 2 trillion dollars on the following infrastructure  
3 plan gradually over the next 10 years, inspired by the HR 5376 Build Back Better  
4 Act:

5 A. 500 billion dollars shall be allocated to help mitigate the Climate Crisis.

6 B. 750 billion dollars shall be allocated to fund hospitals and medical care.

7 C. 750 billion dollars shall be allocated to fund Public Transportation.

8 **SECTION 2.** A. The Climate Crisis shall be defined as any problems that involve the warming  
9 of the planet and the depletion of greenhouse gasses.

10 B. Public Transportation shall be defined as transportation given to citizens  
11 through scheduled public transit systems.

12 **SECTION 3.** A. The Department of Treasury shall be in charge of funding for this legislation.

13 B. The Department of State shall be in charge of placement and allocation of  
14 funds in Section 1.

15 **SECTION 4.** The provisions of this bill shall take effect upon Fiscal Year 2030.

16 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Increase the Regulation of Sulfur Dioxide**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States shall increase the regulations of the Clean Air Act by including  
3 further regulations on Sulfur Dioxide gas productions.

4 **SECTION 2.** A. The regulations on Sulfur Dioxide gas will force a company to receive a  
5 “Prevention of Significant Deterioration” permit from the Environmental  
6 Protection Agency prior to starting any productions that surpass 7,000 tons a year.

7 B. Sulfur Dioxide will be defined as both pure Sulfur Dioxide and any substance  
8 that when released has a potential to be transferred into Sulfur Dioxide gas.

9 **SECTION 3.** A. The Environmental Protection Agency shall be responsible for enforcing the  
10 provisions of this bill.

11 B. Companies in conflict with this bill shall be fined between \$15,000-\$50,000  
12 per day of exceeding the production maximum without a PSD permit and will be  
13 required to shut down production until the company has a obtained a PSD permit.

14 **SECTION 4.** The provisions of this bill shall take effect after two years upon passage.

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Provide Aid to Afghanistan**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States will provide Afghanistan with \$200 million dollars in  
3 humanitarian aid through the use of grants awarded to non-governmental  
4 organizations.

5 **SECTION 2.** A. Humanitarian aid shall be defined as any assistance rendered through the  
6 provision of finances, medicine, or sustenance to a receiving country.

7 B. A non-governmental organization (NGO) shall be defined as any non-profit  
8 group that functions independently of governments towards a humanitarian cause.

9 **SECTION 3.** A. The Department of State’s Bureau of Population, Refugees, and Migration  
10 shall be responsible for enforcing the provisions of this bill.

11 B. A grant shall be awarded through a detailed proposal on the allocations of  
12 funding in regards to humanitarian causes.

13 C. The \$200 million dollars in humanitarian aid will be given to Afghanistan in  
14 two parts, the second part given after an evaluation of the grant’s effectiveness.

15 **SECTION 4.** The provisions of this bill shall take effect one month after the passage of this bill.

16 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Prohibit Texting while Driving**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** It shall be made illegal for any to text and drive while operating a motorized  
3 vehicle.

4 **SECTION 2.** Texting while driving is defined as the composing, sending, or reading of text  
5 messages, emails, or other similar web programs while driving.

6 **SECTION 3.** A. The Department of Transportation shall be responsible for enforcing the  
7 provisions of this bill.

8 B. This law shall be implemented so that a first-time offense is a \$50 fine,  
9 climbing routinely to \$150 for second and third offenses, and a suspended driver's  
10 license for continued offenses.

11 C. The federal government shall substantially decrease federal funding towards  
12 state road infrastructure until this legislation has been implemented into proper  
13 effect as determined by the Department of Transportation.

14 **SECTION 4.** The provisions of this bill shall take effect one year after passage.

15 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Resolution to Provide Support for Student Loan Debt**

**A Bill to Ban Conversion Therapy**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All forms of conversion therapy, practiced at any institution or by any  
3 organization, shall be unlawful.

4 **SECTION 2.** As used herein, “conversion therapy” shall be defined as the pseudoscientific  
5 practice of attempting to change an individual’s sexual or gender orientation  
6 through psychological, physical, or spiritual means.

7 **SECTION 3.** A. The Department of Justice shall be responsible for enforcing the provisions of  
8 this bill.

9 B. Organizations or institutions practicing conversion therapy in violation of the  
10 provisions of this bill shall incur a fine of \$10,000 for each instance.

11 **SECTION 4.** The provisions of this bill shall take effect immediately upon passage.

12 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

**A Bill to Allow Businesses to Request Service Animal Documentation**

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Businesses shall have the right to ask service animal owners to show proper  
3 documentation.

4 **SECTION 2.** A. The United States Department of Justice Civil Rights Division shall create a  
5 national registry and distribute identification to service animal owners as proof of  
6 their legitimacy.

7 B. Documentation shall be defined as certification of proper training from the  
8 agency where the animal is provided.

9 **SECTION 3.** A. The Department of Justice Civil Rights Division shall enforce this bill.

10 B. If a person lacks the proper documentation, they may be denied access to the  
11 goods and services provided by the business.

12 **SECTION 4.** The provisions of this bill shall take effect January 1, 2025.

13 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
