- 5. Neither the Pro nor the Con is permitted to offer a plan or counterplan, defined as a formalized, comprehensive proposal for implementation. Rather, they should offer reasoning to support a position of advocacy. Debaters may offer generalized, practical solutions.
- 6. Crossfire time should be dedicated to questions and answers rather than reading evidence. Evidence may be referred to extemporaneously.
- 7. No new arguments may be introduced in the Final Focus; however, debaters may include new evidence to support prior arguments.

Award points on a per-team basis. The points you award MUST correlate with your decision (NO low-point wins). Remember, this is debate and not related individual oration. All questions concerning rules or misconduct are to be brought to the Tab Room immediately after the conclusion of the round.
